Recap of Election Night Event By MPIC

On June 21, 2018 at the MPIC's annual election night event, our guest speakers were (1) Lt. Rick Schiff who came in place of Capt. Jack Hart, (2) Lt. Marcus Santiago, Park Patrol, (3) Margaret Buitrago, Assistant

District Attorney and Ingleside District liaison and (4) Victoria Weatherford, Deputy City Attorney and Ingleside District liaison. About 30 residents attended.

SFPD Capt. Hart was planning to attend after his earlier town hall meeting with Supervisor Sheehy on an incident in the Noe but the TV cameras and dozens of questions and comments prevented him from leaving.

Lt. Santiago explained that he has 32 rangers covering all of the 230 parks in the city situated on 3,400 acres of land. There were questions on responding to calls at Mt. Davidson. Park Patrol has only one dispatcher and if there is no one available the call is forwarded to police. Call 911 in an emergency or call the non emergency Park Patrol number at 415-242-6390.

Margaret Buitrago explained how she is assigned to the Crime Strategies Unit and advises officers how to conduct a thorough investigation. She also prosecutes cases in court. She gave an example of how she worked on the Monterey Safeway auto burglary case and how such incidents stopped after the arrests

A Block Champion Coming to You Soon

A year ago, people across the Bay Area and the country were stunned by the swift and lethal devastation created by the fires in the North Bay. Tens of thousands of people, many known by our neighbors, were hastily roused in the middle of the night, grabbed what they could, and fled to safety. In true Miraloma style, our community came together and did what we could to help our neighbors to the North. Unfortunately these disastrous fires are occurring once again throughout California, Oregon and many other states.

Miraloma residents are asking: "what can we do here to ensure the safety of our families and friends". Fortunately, MPIC has already launched the Resilient Miraloma Park program with the mission to prepare our community in times of stress be it earthquake, fire or other disaster. Led by your neighbors Robert Gee, Joanie and Guido van Rijn, Jean Perata, Darlene Ramlose and Daniel Homsey – this cohort has been working tirelessly to make smart investments in our community that have helped us be more ready than ever before.

Last year we launched the Block Champion Program with funding secured through Supervisor Yee's Participatory Grant Program (thank you for your votes!). A working group was formed to design this first of its kind initiative. A year later the initial planning stage is coming to a close and is ready to put into action.

The goal of the Block Champion program is to establish one or more neighbors on every block who will organize residents during times of stress. The focus is to protect the health and well being of immediate neighbors, especially the most vulnerable.

All Miraloma Park residents will have an opportunity to participate. The Block Champion Program will support participants by offering first aid training as well as techniques on block organizing during times of stress. Participants will also receive a customized cache of gear and supplies that will empower them to help those around them.

The team is currently putting the final touches on this program. We will be announcing the first enrollment period in just a few weeks. So stay tuned!

Update on the Four Proposed Teresita Blvd Speed Cushions: SFMTA Public Hearing on September 14, 2018

In early July, SFMTA sent a letter, map and ballot to 254 houses along the entirety of Teresita Blvd asking those residents to vote to install either all four proposed speed cushions or none. This method of voting would eliminate the opportunity that localized opposition to the proposed devices could jeopardize a safer corridor for all. The proposed locations were chosen based on adequate distance from curves in the road, speed surveys, and residents' feedback. The cushions are proposed for the following blocks along Teresita Blvd:

- Between Fowler Way and Evelyn Way
- Between Isola Way and Reposa Way
- Between Rio Court and Bella Vista Way
- Between Melrose Ave and Verna Street (closer to Verna)

Modern speed cushions are the most effective and efficient tool for reducing speeding on neighborhood streets with transit service. Speed cushions are speed humps that include wheel cutouts to allow large vehicles, such as MUNI buses and Emergency Response vehicles, to pass unaffected while reducing passenger vehicle speeds. Although similar to speed bumps, they do not create the same vibration or noise and do not necessitate the removal of any on-street parking.

There were 39 yes votes and 19 no votes received. The next step is a SFMTA Engineering Public Hearing that will be held on Friday, September 14, 2018 - 10:00 am at City Hall, Room 416. Comments can be given in-person at the Public Hearing, or emailed to *sustainable.streets@sfmta.com* with the subject line 'Public Hearing'. Notices about the hearing will be placed on street poles along Teresita.

When determining the exact placement of the cushions, SFMTA will look at the voting results and try to place the cushions so they are not directly in front of homes that voted no. Sometimes engineering constraints (roadway utilities, driveways, distance from curves, etc) make this infeasible. SFMTA said they will certainly avoid the 'no' homes where possible.


Miraloma Elementary School: Morning Traffic Flow

The new school year began on August 20 with 395 children and their families entering the school yard for morning circle. This year, about half of the students live in or close to Miraloma Park. Morning traffic around the school is especially busy now with our narrow streets filled with parents parking cars to drop off their children, students crossing streets, garbage trucks, Muni buses and Miraloma residents driving to work.

Once again, Miraloma Elementary and the MPIC have implemented our Traffic and Parking Congestion Plan. This comprehensive Plan, including enforcement and parent education components, has been effective in reducing traffic and parking congestion problems in the vicinity of the School. MPIC looks forward, once again, to a successful partnership with the School in mitigating traffic and parking congestion, and we thank Miraloma Elementary Principal Mr. Noah Ingber for all of the time and energy that he has devoted to working with us.

To assist with congested traffic around the school in the mornings during drop off time (7:45 am - 8:15 am), the school community and Miraloma residents should follow the driving route as shown below:



Miraloma School staff will be on hand during the first weeks of School to provide traffic control and when needed, SFMTA officers will be called to provide enforcement.

Each Presidential term allows for new ideas, changes and rethinking old ways. MPIC has had a history of serving the community with distinction and commitment. One of the Resilient Miraloma Park programs is the Block Champion program that will help neighbors help each other after a disaster. Funded by grant money, the Block Champion program will provide first-aid training and emergency equipment that will be stored in neighbor's garages. One more way MPIC is helping neighbors help neighbors.

The Community Connector program is a big success. Darlene Ramlose, a Miraloma Park neighbor and new Board member, coordinates the program (see article in this issue) that keeps on growing! My husband and I go

were made. She said that Miraloma Park is one of the safest neighborhoods. She talked about the importance of video evidence, about Nextdoor being good for building community but not a replacement for reporting crimes to the police. She is very supportive of the Stop Crime SF program called Court Watch.

Victoria Weatherford explained what the City Attorney's office does. She provided a code enforcement handout which is summarized in the flyer in this newsletter. She mentioned that the MPIC is one of the most active neighborhood organizations in the city and that the "squeaking wheel gets the grease." She answered many questions from residents with some involving vacant properties and the requirement to register such properties with the city.

Lt. Schiff answered many questions as well as provided his thoughts on issues to supplement answers from our other three panelists. He mentioned the value of video evidence and how it is valuable to also have the camera aimed toward the street. He shared his thoughts on the problems with people reporting crimes on Nextdoor instead of calling police first. He urged everyone to call 911 if there is an emergency. He talked about police staffing challenges. Two thirds of the department has less than 7 years of experience. On the subject of suspicious vehicles with paper plates, he said police pull over cars with paper plates all of the time but they take off and police policy is not to pursue them.

Residents asked questions about skateboarders, cars speeding on Portola near Marne, to what extent crimes are committed by repeat offenders, a comment that there is a relationship about local crime and the proximity to juvenile hall, crime by juveniles, concerns of fireworks on Mt. Davidson on July 4 and empty properties in the neighborhood.

One of our senior residents expressed much gratitude to the police and district attorney's office for their response to a man who kept trying to enter her home where she lived alone. Lt. Schiff mentioned that he recalls being one of the responding officers to that incident.

All of the panelists stayed after to answer questions from the residents.

Guilty Pleas in Three Criminal Cases

The MPIC Safety Committee has been in communication with the assigned Asst. District Attorneys (ADA) for the following three criminal incidents in our community since the arrests of the defendants. All of the cases have now been resolved with guilty pleas.

GUILTY PLEAS - Susan Tran and Jason Alba

This was the February 14, 2018 arrests at the 400 Block of Melrose. The police executed a search warrant and found methamphetamine packaged for sale, two firearms, stolen computers, id's, dozens of ammunition rounds, almost \$3000 in cash, stolen credit cards, and a master key to Ford vehicles. Alba had several outstanding felony convictions for drug possession and sales involving a firearm. Tran had several felony warrants for her arrest as well.

On July 15, 2018 both pled guilty to felonies for possession for sale of a controlled substance. Both are still in custody and due to be sentenced on August 13. For Tran, the proposed sentencing is 2 years state prison, stay away order from the location, warrantless search and seizure, no weapons allowed and restitution. Tran will probably

spend 1 year in custody, 1 out on mandatory supervision. For Alba, the proposed sentencing is 3 years of adult probation, 1 year in county prison, stay away order, no weapons allowed and restitution.

GUILTY PLEA - Phouthalom Phasavath

This was the December 19, 2017 vehicle break in at the 200 Block of Evelyn Way. The defendant was wearing a ski mask and left the scene in a vehicle with paper plates. He was caught shortly thereafter down on Monterey Blvd. with the stolen property, burglary tools and mask. The defendant just pled guilty, but the judge agreed to a DEJ or "deferred entry of judgment." This is a sort of lightweight probation, where if the defendant adheres to certain terms over a period of time, the judge won't even enter the guilty plea and it will be purged from the record. The reason the judge granted the DEJ is because the defendant has minimal criminal history and is still quite young. The intent is to not set a young person down a path of incarceration, more crime, recidivism, and further disruption to communities like ours. The DEJ approach happened over the objection of the ADA. However, the defendant has now violated the terms of the DEJ and failed to appear in court and a warrant is currently outstanding for his arrest. Neither the ADA nor the Court believes the defendant is an active safety threat to the community and that it's likely the police will catch him on a minor infraction and then bring him in to be sentenced to a felony. At that point he will forfeit his credit for time served thus far.

GUILTY PLEA -James George Paras

This was the September 2017 Bella Vista Way/Teresita Blvd multiple hit and run and DUI incident. The MPIC recently submitted a letter to the judge expressing the community's interest in a speedy resolution to the case. In June, the defendant pled guilty to driving under the influence of alcohol and hit and run causing property damage. He has been sentenced to four years of probation, 90 days home detention, alcohol treatment, DUI classes, fines and fees, and he has been ordered to provide economic reimbursement to anyone who suffered property damage or any other economic loss as a result of his crimes. The Adult Probation Department of San Francisco should be reaching out to the victims in the next six weeks to request restitution amounts.

That doesn't mean that an actual incident happened, it just means that someone called, in other words, someone could call about a suspected incident but it might turn out not to be an incident at all. The SF Police Data website is still not reporting incidents so there isn't any information on resolutions. We have reached out to Capt. Hart to ask him about the uptick in burglaries.

Hawks Soar over Miraloma Park


Does it seem to you that there are more hawks in the sky in the Fall? You're right! Every Fall the Bay Area sees an increase of hawk species – Red-tailed Hawks, Red-shouldered Hawks, Cooper's Hawks, Sharp-shinned Hawks, Broad-winged Hawks and other raptors. One great place to observe the hawk migration is on Hawk Hill. Hawk Hill is in the Marin Headlands of the Golden Gate National Recreation Area, just north of the Golden Gate Bridge.

Every day and weather permitting, from mid-August to early December volunteers of the Golden Gate Raptor Observatory (GGRO) count the number of hawks passing over Hawk Hill. Other GGRO

volunteers trap and band the raptors. Many of the hawks use the thermals of the Marin Headlands to cross the Golden Gate, and several of the hawks continue their flights over Miraloma Park. Look for them flying over Mount Davidson or soaring over Glen Park Canyon and Twin Peaks.

Want to learn more about the raptors' migration? Attend the GGRO's Hawk Talks and Raptor Release. The event takes place on Hawk Hill every Saturday and Sunday during September and October; heavy fog or rain cancels. (There are no programs during the Blue Angels' airshow.) The Hawk Talk begins at noon. A GGRO volunteer talks about hawk migration and identification and GGRO's long-term monitoring of raptors. And, if you're lucky, you'll be able to see a hawk up close. When possible, a hawk that has been banded by a GGRO volunteer is brought to the Hawk Talk. After a discussion about the banding program, the hawk is released for all to see.

The Hawk Talk and Raptor Release is free! It's open to the public and no advance reservation is needed. Look for the big banner just west of the main Hawkwatch platform on the very top of Hawk Hill. Peak hawk activity usually occurs from mid-September to early October. Whenever you go, it's good to arrive by 11:30am, watch hawks in the sky, stay for the talk and longer if you'd like. Parking is limited and fills fast! You can bike to Hawk Hill or take SF Muni 76X to the Marin Headlands. Before you visit, check road conditions by visiting https://www.nps.gov/goga/index.htm.

Roof Decks

NEW: Draft on Roof Deck Policy

Roof decks are an opportunity to provide an outdoor amenity area to enrich open space. However, because of their elevated location, they also represent a potential increase of uses that can negatively impact adjacent residents. Therefore, such projects need to be carefully considered in the design review process.

The Planning Commission has asked the Planning Department to develop preliminary recommendations toward ensuring a consistent approach to evaluating rooftop features. This includes taking the following considerations:

- Size of decks, and the cumulative impacts of multiple decks:
- Availability of usable open space at grade;
- Appropriateness of front decks vs. balconies;
- Roof decks serving as common vs. private usable open space;
- Pattern of roof decks in the surrounding neighborhood;
- Greening of rooftops; and
- Quality of life impacts

At the August 30 Planning Commission hearing, Planning staff gave an informational presentation with a recommended roof deck policy that attempts to strike a balance between allowing for the reasonable enhancement of outdoor open space on the roofs of low-density residential buildings, which will improve livability in a dense, urban setting, while protecting the quality of life for adjacent neighbors.

Getting Started

Your roof deck project will require the submittal of a Building Permit Application. Depending on the scope of work and zoning district of your property your project may be approvable over-the-counter (OTC), or it may require Neighborhood Notification and several accompanying Pre-Application steps.

It is recommended to visit or call Planning staff at the Planning Information Center (PIC) early in the planning of your project. The PIC is at 1660 Mission Street, 1st floor and may also be reached by phone at (415) 558-6377 or via email at *pic@sfgov.org*.

We also recommend you contact the Department of Building Inspection (DBI) to confirm their requirements before submitting your Building Permit Application. They can be reached at (415) 558-6088, or at 1660 Mission Street 1st floor Public Information Counter.

Understanding What's Allowed

New decks on roofs are regulated by the San Francisco Planning Code. To maintain the character and purpose of distinct areas in San Francisco, the City's geography has been divided into distinct zoning use districts (view these zoning use districts on the San Francisco Zoning Map and Section 201 of the Planning Code). For each activity or use of land in any given zoning district, the Code states if that activity or use is either: Permitted; Conditional; or Not Permitted. Therefore knowing the zoning district of your property will help you identify what specific limits may apply to your project and which application materials you will need to submit.

You can find the zoning use district and height limits of your property on the Find My Zoning page, or directly from our San Francisco Property Information Map by entering your address or Assessor's Lot and Block number and click the "Zoning" tab. Once you know the zoning use district of your property, you can reference our useful handout, "Summarizing San Francisco's Residential Zoning District Controls," which summarizes regulations and Code controls for projects in residential districts.

Other Things To Consider

In addition to the zoning district and land use regulations in the San Francisco Planning Code, your application will also be reviewed under provisions in all of San Francisco's Municipal Codes, the San Francisco General Plan, and Department policies based on a number of cri-


teria (e.g. the historical significance of your property, the environmental impact of your project, or other regulations).

Neighborhood Notification requirement

The Neighborhood Notification requirement is dependent upon whether the roof deck, and the access to it, is within the buildable area of your lot (see below). If your deck requires "notification," a mailing notifying the nearby neighbors of your proposed project is sent to adjacent neighbors only and they are given a period of 10 days to respond with concerns (as compared to a 30-day notice to owners and occupants within 150 feet of the site, as is done with the standard Neighborhood Notification process).

"Buildable area of the lot" means the area that is not part of the required yards or set backs under the Planning Code and within the applicable height limit. (Zoning Administrator Bulletin 5 explains buildable area for Residential Districts.) For residences in commercial zoning districts, the rear yard requirement is typically 25 percent of lot depth. You can apply the rules of a 25 percent rear yard requirement shown in Zoning Administrator Bulletin 5 to determine yard requirements for residences in commercial districts. (See Decks & Stairs if your deck project is not on a roof.)
