#### PRESIDENT'S MESSAGE


By the time you read this, I will have begun my two month term as acting MPIC President. I urge you all to get involved in the Club: join a committee, sign up to pull weeds at the clubhouse, meet neighbors, serve on the board. New ideas and new energy are welcome. Many writers have ascribed the rise of division and contentiousness in our contemporary society to the decline of small community organizations: PTAs, fraternal organizations, rotary and garden clubs, bowling leagues. Here's one right on your own block. We definitely don't always agree on every issue, but have more in common than social media friends who share every opinion.

Stephanie Boudreau Ma, President for July and August, organized a board potluck in late July. It was a wonderful event and allowed us to meet some of our newer members in person for the first time. The clubhouse has been reopening to some of our regular renters, after the long COVID shutdown. Universal indoor masking signs were posted the first week of August and the last chapter of the pandemic has yet to be written. The next board meeting will be on Zoom, September 2 at 7:00pm. As always, in order to attend or have an issue placed on the agenda please email miralomapark@gmail.com.

Much of the August board meeting was taken up with discussion of the City's 2022 Draft Housing Element. This document will express the values guiding SF housing policy for the next eight years. The current version and comments can be seen at www.sfhousingelement.org in dizzying complexity. Although, for instance, the need to "repair the harms of historic discrimination" is a clearly laudable objective, less obvious would be the policies implemented to "ensure equitable geographic distribution of new multi-family housing throughout the city" or "identify community benefits that would allow streamlined approval of mid-rise multi-family buildings". At the state level SB9 and SB10 are currently working through the legislature. These are the latest versions of a campaign to invalidate local building codes through state level mandates. These could allow up to six units on residential lots without a need for garages, yards or public hearings, and override zoning, environmental and land protections. The argument against these bills has been made well on the editorial pages of the LA Times. The underlying matter is by no means black and white; California has, in recent decades, built inadequate housing, especially affordable housing. An August 1 editorial in the Chronicle identified single-family zoning as SF's "most toxic monument to racism". There's a lot of nuance in these areas and I encourage all of you to study them. If you believe that

public housing policy has little effect on your day to day life, imagine trying to park on your block when every other lot contains six units. Karen Wood and Karen Breslin of the MPIC Zoning and Planning committee have been studying all of this for many years. I'll invite them to share their knowledge in future issues.

I was curious about the work that has been taking place

this summer on the rock outcropping above O'Shaughnessy Blvd and below Marietta Drive. My daughter loved to explore the 'rock mountain' when she was small. I remember walking there to view a city illuminated only by candlelight on the night of the 1989 Loma Prieta earthquake. On August 3, I spoke with Tim Bokelman of Drill Tech, the firm that has been contracted to complete this project for the SF Department of Public Works.

The "O'Shaughnessy Blvd Central Slope Permanent Restoration Project" will involve drilling approximately 65 holes into the face of the cliff, 5" in diameter and approximately 25' deep. The majority of these will contain threaded rock bolts, which will be grouted into the stone and secure large nuts and washers, and serve to pin the face of the cliff to the underlying material, similar to the washers one sees on the face of brick buildings which have undergone earthquake retrofitting. The remaining holes will contain threaded rods which secure wire mesh

draping over the brow of the cliff serving to restrain rocks that break free. The city has prescribed that care be taken that the mesh be made to conform to the rock face and be minimally apparent. Also in the scope of work was removal of loose debris at the base of the cliff. Approximately 230 tons of material were trucked away in order to create a level shelf at the cliff base so that any falling rocks will remain there rather than be deflected onto the roadway.

I asked Tim if they had made any interesting discoveries

during the project, hoping to hear tales of ancient Ohlone cliff dwellings or pirate treasure. At the end of April, song sparrows were found nesting on the slope and, in keeping with California law, the project was placed on hold until late May when the fledglings left the nest. The project should be complete around the beginning of September.

## **FAREWELL AND THANK YOU DEBRA ESTRIN**

It is with both gratitude and sadness that the MPIC announces our long-time chair of the Safety Committee, Debra Estrin, will be stepping down this fall. She has brought an incredible amount of knowledge and expertise to the MPIC.



Debra was recognized by the SFPD as the July "Ingleside Citizen of the Month." Born and raised in the Miraloma Park neighborhood, with degrees in Criminal Justice Administration and the San Francisco Law School, Debra's work experience has had her working in law enforcement with

the State and Federal governments, at the State Bar of California, as a Prosecutor for the Tulare County District Attorney's Office, and as a self-employed attorney. Debra's involvement in community work took her to organizations that provided mentoring and scholarships for former foster youth that had a desire to attend college, and assisting teens that had dropped out of high school or had fallen behind scholastically. For the past three years, Debra has been on the Board of Directors of the MPIC and Chair of the Safety Committee. The Safety Committee promotes crime prevention through education, gathers and shares reports of criminal activity and safety tips with the Miraloma Park neighborhood, and performs safetyrelated advocacy for Miraloma Park with City agencies. Debra was invited by then-Ingleside Captain Hart to be a member of Ingleside Station's Community Police Advisory Board, providing her with the opportunity to be involved in National Night Out.

## MPIC BOARD MEMBER **ELECTIONS SCHEDULED FOR OCTOBER**

**MPIC** 

The election of MPIC Board Members will take place in October 2021. Given the current COVID-19 situation, the election will be conducted electronically and by mail-in paper ballots. Here is important information about the election.

#### **ELIGIBILITY**

Eligible to vote are MPIC dues-paying members who are 18+ years old and who are members of MPIC as of September 6, 2021. Miraloma Life is distributed to every home in Miraloma Park. For the purpose of the election, "eligible voters" are those who pay annual dues to MPIC. A Membership Application can be found online at <a href="https://miralomapark.org/join/">https://miralomapark.org/join/</a> or call 415-322-0211 to request a membership application and mailing envelope. If you are not currently a dues-paying member and want to vote in the election, the MPIC must receive your annual dues by September 6.

#### **HOW TO VOTE**

Eligible voters will be able to vote electronically or by paper ballots. In early October MPIC will email a link to a ballot to all members for whom MPIC has an email address. The link will advise you how to vote electronically. In addition, the October issue of Miraloma Life will contain a paper ballot and instructions for those who wish to vote by mail. Eligible voters should cast one ballot, either electronically or by mail.

#### WHEN VOTING IS OPEN & CLOSED

The polls open on October 6 and will close at midnight, October 13. Electronic ballots may be cast between October 6 and 13. Mail-in ballots must be received by MPIC by October 13.

All votes will be tallied on October 14. MPIC representatives will count ballots cast by eligible voters and will ensure that only one vote per person is counted. The results of the election will be announced on the MPIC website and will be published in the November issue of Miraloma Life. Photos of the candidates for office and their brief statements are included in this issue.

## FREE MUNI SERVICE FOR SF **YOUTH UNDER 19 &** SFMTA RESTORES #36 BUS

During the pandemic Miraloma Park lost #36 transit service. SFMTA has been meeting with Supervisor Melgar twice a week to help restore transit service to the city and especially District 7. On August 15th SF MUNI restored the original #36 Teresita to its original route. It will not be combined with the #52 serving Diamond Heights. The frequency for this restored route will be every ½ hour. Miraloma Park has had recent struggles with timing the #36 on Myra Way. Transit planners have seen how two buses cannot pass each other on Myra Way without damage to sidewalks and to other infrastructure.

This new/restored service starts in time for the start of the 2021 school year. Mayor Breed also has announced that all youth under the age of 19 will have FREE MUNI service. This will allow parents the opportunity of using MUNI to transport their families with less expense.

Miraloma Park neighbors have stated their concerns to the SFMTA. Your voice is important and this transit service should reflect the community needs. ## RECENT NEXTDOOR **POSTINGS REGARDING AUTO BURGLARIES AND GARAGE BREAK-INS**

Reprinted below is a posting I made to Nextdoor in July 2021.

Although the number of auto burglaries and garage door break-ins in Miraloma Park are disconcerting, I find it also disconcerting that many people are not taking precautions to minimize the risk of becoming a victim. The Miraloma Life newsletter, which is delivered to over 2,200 homes in Miraloma Park, lists monthly crime statistics in the neighborhood that indicate an increase in these types of crimes. In addition to bringing this situation to the attention of the residents, there have been articles repeatedly written in the newsletter advising people NOT to leave valuables in their vehicle, not to leave their garage door remote in their vehicle, and how to secure their garage door in a variety of ways.

#### **Recent Nextdoor Postings Regarding Auto Burglaries and GarageBreak-Ins**

Additionally, a Safety Town Hall was held on Zoom in May, where these areas of concern were addressed with Ingleside Police Captain Jones and Assistant D.A. Evanthia Pappas. If you cannot park your vehicle in your garage, make sure there are no valuables in your car, and never leave your garage door remote in your car. You can secure your garage door in a variety of ways, which include using slide bolts or a lockdown brace, reinforce garage door windows with a protective coating, install a garage shield that blocks a hook from reaching the manual release, tie up the manual release cord, or use a zip tie to lock the manual release handle in place (make sure you have wire cutters close by to break the zip tie in the event of an emergency).

There are monthly community meetings with Captain Jones that you can also attend in person and via Zoom.

SFPD is understaffed. For years there have been requests for more police patrols in Miraloma Park. However, this is not something that will happen in the near future. Ingleside Police Station covers seven neighborhoods, most of which have much more serious criminal activity. That being said, we need to take some responsibility to reduce the potential of becoming a victim. We also need to watch out for our neighbors.

If you see something suspicious at or near your homes, call the non-emergency number or 9-1-1 if it's an emergency. Following these tips is not a guarantee that you will not be a victim of an auto burglary or garage door break-in, but it certainly will reduce the chances.
