The San Francisco Fire Dept. has reorganized the City's Neighborhood Emergency Response Teams (NERT) teams into Battalions. Miraloma Park is in Battalion 9 which also includes NERT teams from Mt. Davidson Manor, Balboa Terrace, Sunnyside, Park Merced/Stonestown, Lakeside, Oceanview, Ingleside, Excelsior and Visitacion Valley neighborhoods. MPIC's Joanie van Rijn is the Miraloma Park NERT coordinator and has been elected the Batt 9 Lead Coordinator and will be responsible for hosting and designing the Batt 9 meetings for the year.

The first NERT Batt 9 meeting was held on July 27th and hosted by the MPIC at the MPIC clubhouse. We met the new NERT Fire Dept. representative, Capt. Brandon Tom and Tracey McTague, Outreach Coordinator for NERT. The meeting was attended by 36 NERT members from all over Batt 9. MPIC hosted a light dinner for everyone.

The agenda was packed and the highlight was playing a true or false game testing everyone's knowledge of NERT techniques as well as a game of team work balancing a ball while racing across the room. MPIC gave out headlamps as prizes and everyone won!

DO DRIVERS OBEY THE STOP SIGNS AT THE INTERSECTION OF TERESITA BLVD AND STILLINGS AVENUE?

That's the concern expressed by neighbors who shared their observations that drivers are not obeying the 3 stop signs, especially cars that are approaching southbound on Teresita. Requesting SFPD traffic enforcement is not an option as they have told us they don't have the resources. The SF Chronicle recently reported that traffic enforcement has declined 97% over the last 8 years! Driver education is not a solution since all drivers know they are required to obey stop signs.

In response to neighbor concerns, the MPIC in March 2023 submitted a 311 request for SFMTA to conduct a traffic study of the intersection at Teresita Blvd. and Stillings Ave. to confirm that drivers are not obeying the stop signs and to determine how to engineer the intersection to ensure drivers obey the stop signs.

SFMTA must first conduct a traffic study of the intersection. Assuming SFMTA agrees (but that isn't a guarantee) that a substantial percentage of drivers do not comply with the stop signs, possible solutions could include one or more of the following:

- (1) consider whether to place flashing solar powered signs notifying drivers of upcoming stop signs,
- (2) at the intersection consider placing white plastic no hit posts on the wide white pavement striping to narrow the lane towards the intersection so that cars would slow as they approach the intersection,
- (3) consider painting the approaches to the intersection between the wide white pavement striping and the curb a different color to give the visual appearance of a narrower street so that cars would slow as they approach the intersection,
- (4) consider installing warning pavers, grooves or low studs at an appropriate distance before the stop signs to alert distracted drivers and refocus driver attention on the approaching stop signs. Warning pavers such as the yellow Armor Tile are commonly used at crosswalks. This novel idea was suggested by a resident who previously submitted a 311 ticket,
- (5) consider whether a solar operated sign flashing the speed of the vehicle should be installed to alert drivers of their speed. SFPD has previously placed their mobile speed radar unit on Teresita Blvd. We think a flashing speed sign does little to deter speeding.

Since March of 2023, SFMTA has taken no action on our 311 request. In July 2023, MPIC asked Supervisor Melgar's office to follow-up with SFMTA. SFMTA responded that the 311 request is in the SFMTA traffic engineering team's queue for evaluation but that the team is currently working through a number of other safety requests throughout the City. Supervisor Melgar's office then asked for an estimated time of completion. SFMTA responded that their engineering team is stretched thin and currently evaluating Brotherhood Way and that they intend to focus their attention on the Teresita Blvd. and Stillings Ave. intersection once they've completed their assessment on Brotherhood Way.

MPIC will continue to follow up with Supervisor Melgar's office and SFMTA.



REMEMBERING PAST TRAGIC EVENTS, NOT AS EASY AS IT SOUNDS

Please place your OK sign in the front window for the first three weeks in October. Remember October 17th, 1989

Is it just my aging brain or are other Miralomans suffering from the same malady? Long term memory, particularly of events I did not directly experience, drift off into the distant past much too quickly. October 17th, 1989, I still vividly remember as our house on Los Paltos "vibrated" violently. My wife and I huddled with our two children huddled in what was perceived to be safe space for the duration of the shaking and well beyond. It was intense and incredibly scary. Our story and that of others who lived in San Francisco at the time are still being told today.



The fire that recently leveled a good part of Lahaina, Hawaii, has resulted in a death toll that seems to have stabilized at 97 as of this writing. Sixty-six residents are still unaccounted for. Around 2200 buildings, mostly residential, were

destroyed. However, much of the damage included Historic Lahaina where restaurants and local shops were burned to the ground. Lahaina has been the "go-to vacation spot" whenever my wife and I go to Hawaii. Sadness still clings, and will continue to cling, in our hearts.

But more remote disasters, though horribly real to those who experience them, are erased, at least from my brain, all too quickly. What comes to mind are two recent hurricanes in Florida, as well as the very intense heat waves in Arizona, Texas and the Midwest. Remember the devastating earthquake in Turkey and Syria only a year or so ago? So very distant in my mind. Now Morocco has been seriously impacted by a major earthquake in which early counts indicate over 2800 deaths, and Libya had an extraordinary rainstorm and subsequent dam collapse wiping out thousands of buildings, with incredible loss of life in an instant, as of this writing. I wasn't there, I did not experience it. How long will that horrible disaster affecting so many people stay with me? Long enough to where I can help in some way, even with a small donation. But if I don't personally experience it, memory is fleeting indeed.

Placing that OK sign in the window for the first three weeks of October is an active response to what has happened and will most certainly happen again. Participating is food for the brain that will keep reminding us as a collective to be prepared and ready for any disaster that might befall us be it large or small. It helps remind all of us of the resilient community we are, both as individual households and as a collective Miraloma Park.

THE CITY'S 311 SYSTEM IS FOR YOU TO REPORT QUALITY OF LIFE ISSUES

We want to remind everyone that the City's 311 service is there for citizens to easily report quality of life issues by sending pictures, a brief description and a map based location. The requests are routed to the appropriate City agency. You can report your issue by:

1. calling 311 or
2. submitting the request on the updated website at <https://sf.gov/topics/311-online-services> or
3. using the SF311 mobile app that you can download to your mobile devices.

Whichever way you submit your request, make sure you write down the service request number so that you can track your request. We've seen many 311 requests just get closed with the issue not getting fixed. Residents have reported that they didn't know that their requests were closed without any action.

Here are some of the more popular 311 requests we've seen in Miraloma Park:

Trash, Graffiti and Street Cleaning

The City does a pretty good job of responding to these requests quickly within a day or two.

- Request street or sidewalk cleaning. The response is usually quick especially when there is human waste involved!
- Report illegal dumping activity. This is a regular occurrence in Miraloma Park.
- Report street garbage containers that are overflowing.
- Report graffiti issues especially on bus shelters, street poles, mail boxes and other structures.

Parking Concerns

The City does a pretty good job of responding to the following requests quickly.

- Report an abandoned vehicle. Unfortunately, there are stolen cars abandoned in Miraloma Park all the time.
- Report broken traffic signs.

Street and sidewalk maintenance

- Report pothole and street issues. The City usually responds quickly to these types of requests including repainting faded red zones.
- Report sidewalk issues such as sidewalks that are cracked or raised by tree roots. This is a very common reported issue in Miraloma Park. Unfortunately, our experience is that the City is very slow to respond to sidewalk issues supposedly because they don't have the staffing.
- Report a damaged or fallen tree. The City will remove the fallen tree quickly especially if it blocks a street. But they are very slow to respond to dealing with trees that are uprooting sidewalks.
- Report flooding or water leaks and sewer backups.

Residential building concerns

- Report neglected or run-down houses where there is blight on properties that have significant visible damage, deterioration, or debris. There are a fair number of vacant houses in Miraloma Park. The City has a law where the owner of a vacant house is required to annually register with the City and continue to secure and maintain vacant property. The registration cost is \$818 per year.
- Report illegal unpermitted work or other code enforcement issues. The Dept. of Building Inspection will usually send someone out to the property but inspectors can't enter the buildings without being let in by the occupants.

Please contact the MPIC if there is a 311 service request that is a community wide issue or just doesn't get resolved after a long period of time. The MPIC will follow-up with the City agency as well as with Supervisor Melgar's office.
