On May 22 Mayor Breed announced that San Francisco's [summer camps and programs can reopen](#) on June 15 with limited capacity and with modifications intended to prevent the spread of COVID-19.

On May 22 SF's Department of Public Health (DPH) issued a Health Order for summer camps and programs that is consistent with the State's guidelines. The Order applies to public and private camps and summer programs, and includes safety measures such as temperature screenings and enhanced cleaning. Great Plates Delivered SF – New Food Program for Seniors

San Francisco has launched [Great Plates Delivered SF](#) to provide seniors access to delicious meals made by local small businesses. Eligible seniors must be 65+ or 60 - 64 with certain underlying health conditions; live alone or with another eligible senior, and earn less than \$74,940 for a single-person household or \$101,460 for a two-person household. Participants will receive up to three free meals a day provided by local food vendors. All deliveries are contactless for safety, and all individuals delivering meals are subject to background checks.

COVID-19 Tests – Increased Availability

San Francisco has expanded access to COVID-19 tests through [SF.gov/GetTestedSF](https://sf.gov/GetTestedSF). New Testing sites have been opened, including one at SF City College Campus. Eligible for the tests are:

- Any worker that serves San Francisco and who leaves their home to work can get tested for COVID-19, regardless of symptoms or exposure.
- Any person living in San Francisco with at least one symptom of COVID-19 or who has been exposed to someone with a confirmed case of COVID-19 can get tested.

You need to make an appointment in order to get a test. You do not need medical insurance to get tested. You do not need a doctor's note to schedule a test.
